#### **BERNALILLO COUNTY UPDATE:**

Bernalillo County is currently working on updates to our food regulations which include adopting the 2017 food code, temporary food establishments, and manufactured foods. We plan to introduce the final draft to the commission before the end of the calendar year. Last year we conducted a surveillance of Listeria Monocytogenes and collected 27 deli slicer swab samples from 18 food establishments. There were no positives samples for LM. We also collected samples of soft ice cream, shakes, and paletas (frozen fruit treats) for coliform count analysis at 20 food establishments. A standard of 40 CFU/g was borrowed from the Texas Food Establishment regulations. There was a total of 52 samples taken from the 20 food establishments. There were 16 samples that were equal to or greater than 40 CFU/g. 11 samples were greater than 100 CFU/g. The majority of the elevated coliform were due to improper cleaning and sanitization of equipment. Follow up visits were conducted with facilities with high levels to inform the importance of proper cleaning and sanitizing procedures.

#### INDIAN HEALTH SERVICE UPDATE:

The Albuquerque Area Indian Health Service has had a very eventful beginning to 2019. The partial government shutdown impacted several operating divisions within the agency, including the Division of Environmental Health Services (DEHS). Shortly after the shutdown ended, Ms. Debra Grabowski, DEHS Director, announced her retirement at the end of February. After dedicating over 40 years of public health service to the City of Albuquerque and IHS, Debbie's excellent leadership and experience will be greatly missed. DEHS continues working towards fulfilling all of the requirements for the FDA Voluntary Retail Food Regulatory Program, a nationally recognized rigorous food program improvement model. Other work includes building capacity to better serve tribal communities in all facets of environmental health and injury prevention including: child passenger safety, elder fall prevention, and school bus transportation safety

# Want to stay healthy this cold and flu season? Wash your

hands! Did you know that handwashing is the number one way to avoid getting sick and spreading illness to others? But we need to do it correctly! For the most benefit follow these steps. Step 1: Wet your hands with clean running water (warm or cold will do!). Step 2: Apply soap and rub your hands together. Make sure to get between your fingers, the backs of your hands, under your nails, and your wrists and thumbs. Step 3: Continue scrubbing for at least 20 seconds. Step 4: Rinse your hands with clean, running water. Step 5: Dry hands with a clean paper towel or let them air dry. You should always wash your hands: before, during, and after preparing food; before eating; before and after caring for someone who is sick; after using the bathroom; after chang-

ing diapers; after handling garbage; and after blowing your nose, coughing, or sneezing. Finally, alcohol based hand sanitizer containing at least 60% alcohol can be used to clean hands in a pinch, but should not replace washing your hands with soap and water.
